- Mutual Aid Calls for Month of March 2022 - (47)
- Open Discussion – by, Chief Todd Parker, w/Ward 6 Fire Protection District No. 1
 - ☞ Woods Fire on Bud Bennett Road
 - At 12:35pm, Ward 6 was dispatched to a woods fire on Bud Bennett Road
 - Upon arrival, LA Dept of Agriculture and Forestry was on scene attempting to contain the fire with several dozers.
 - The high winds and low humidity made for extreme fire conditions that continuously jumped fire lanes.
 - Ward 6 utilized the mutual aid system and requested apparatus and manpower from multiple agencies to provide structure protection and cover our fire district should any other emergencies occur.

 - The fire burned approximately 800 acres of timber. There was no damage to any structures and no injuries to any emergency responders
 - 6 homes were evacuated as a precautionary measure, residents were able to return to their homes at around 7pm
 - There will be smoke in the area over the next few days as LDAF crews mop up hot spots.
 - Ward 6 E5 and Service 8 are currently working a grass fire on Hwy 389 that was caused by a downed power line
 - Thank you to all the hard-working volunteers that spent over 8 hours working this incident

Regulatory ALERT/RMP Tabletop Drill After Action Report:

- Presented by Mr. Greg Satterfield/Mr. Chris Chaisson w/LyondellBasell
 - ☞ ***How Facilities Impacted:***
 - All LyondellBasell manufacturing facilities (referred to as “stationary sources” under the Clean Air Act) located in the United States which are covered by 40 CFR Part 68
 - ☞ ***Summary:***
 - On November 21, 2019, the EPA released the RMP Reconsideration Final Rule, modifying and improving the existing rule to remove burdensome and unnecessary amendments while maintaining appropriate protections and ensuring first responders have access to necessary safety information
 - On December 19, 2019, the EPA published its RMP Reconsideration Final Rule in the *Federal Register*

EMS 8 HEALTHCARE: Mark Conner, Acadian Ambulance, Chairman –

Discussed - Louisiana Region R5 ESF-8 Health & Medical Coalition Meeting met on Monday, March 28, 2022, to discuss:

- ***Burn Kits Assembled & Deployed***
 - ☞ 1st of next month
 - ☞ Region 4
 - ☞ Region 5
 - Region 5 owes their own drone
- ***Dr. Cavanaugh – Provided public health and COVID updates***
 - ☞ COVID numbers and positivity rates are at all time low
 - ☞ Testing contracts managed by the state – going into “warm status”; encourage hospitals to consider their surge testing strategies and plans at EDs with this option being scaled back
 - ☞ LNG supported sites are going to begin demobilizing

- ☞ Opioid updates – over 100 deaths in 2021 for Calcasieu parish
 - Has over doubled in past two years
 - Fentanyl is a big contributor
 - LE and PH/ESF8 working closely to help combat and discuss challenges/opportunities to combat
- **Frances Arledge provided the hospital preparedness program and statewide updates**
 - ☞ Burn Surge Annex Planning
 - A draft state level plan has been developed and is being reviewed and modified by HCC leads/DRCs
 - HCC members and hospitals should expect to see drafts of their region 5 adopted plan and provide feedback
 - Burn push packs have been developed and are hoping to be deployed to the field in the month of April – these packs are designed to help provide care in the field, at rural hospital or at Trauma centers to help manage up to 10 burn patients with mild-moderate burn injuries
 - Burn Screen developed in the portal to provide LERN visibility on available beds; message groups are being developed to put burn hospitals on standby of burn MCI events as well as eventually including the southern region burn hospitals (Southern US region)
 - ☞ Supply Chain and resources assessment
 - HCC must conduct assessments of supply chains and resources available
 - Currently the ESF8 portal captures some basic resource information in the Resource Management and in the MSTAT systems
 - Additional resources and supply chains are needed to be captured to meet this requirement and assist with mitigation strategies
 - Hospitals should expect to see a resources/supply survey pushed out at the state level and should provide responses to that survey – only 8 questions, should take no longer than 5 mins
 - Additionally, hospitals should make sure they update the Resources Management, Resources tab and the MSTAT critical infrastructure section of the ESF8 Portal
 - ☞ Hurricane Improvement Planning – Communications and Info Sharing
 - ESF8 Portal and At-Risk Registry platforms are essential – there will be training for introductory level users and refreshers on the systems at end of April
 - At state level, focus is on identifying and maximizing redundancies in communications (PACE planning)
 - All hospitals should do the same – review the ESF2/Communications Lunch and Learn recording (linked in the Slide set) to help assess the risk assessment and understand PACE planning
 - ☞ Upcoming Trainings – see slides
 - Future Cyber Workshop details to come soon
- **Scott Kyle provided regional updates**
 - ☞ Reviewed the Regional HVA summary
 - ☞ Reviewed the NIMS courses and the suggested levels for various hospital/healthcare response partners
 - P. Destout encouraged the practical use and participation of NIMS
 - ☞ emPOWER data – this data set is sent quarterly by CMS, de-identified
 - Helps show by parish the number of patients who are vulnerable – i.e. vents, oxygen, etc
 - Can be identified and sent in preparation for a storm – hospitals and regional coordinators should understand approximate numbers of these citizens as this may put an extra surge of patients on the hospitals
 - ☞ Redundant communications drill – April 4th, will be conducted in conjunction with a radio roll call
