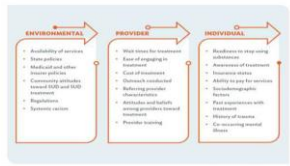

Barriers to Care for People at Risk of Overdose

- Only 4 million of the 41.1 million people aged 12 or older who needed substance use disorder (SUD) treatment received it.¹
- Among 2.5 million people with opioid use disorder, only 11.2% received medication for opioid use disorder (MOUD).²
- Among people who felt they needed SUD treatment but did not receive it, 40% reported they were not ready to stop using substances.³

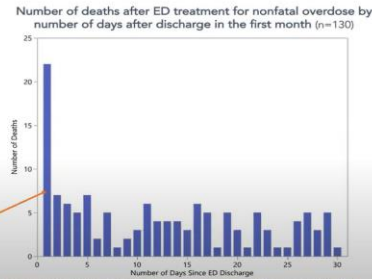

ED patients with non-fatal opioid overdose

- 5% one year-mortality post-ED discharge
- Of patients that died, 20% died in the first month
- Of those that died in the first month, 22% died within the first 2 days

CONCLUSIONS AND RELEVANCE Among opioid-dependent patients, ED-initiated buprenorphine treatment vs brief intervention and referral significantly increased engagement in addiction treatment, reduced self-reported illicit opioid use, and decreased use of inpatient addiction treatment services but did not significantly decrease the rates of urine samples that tested positive for opioids or of HIV risk. These findings require replication in other centers before widespread adoption.

Discussed - Southern Technical Aquatic Rescue & Resources

- SWLA Mutual Aid Association is planning to host the Southern Technical Aquatic Rescue & Resources in our area to conduct a Swiftwater/Flood Water Awareness & Operations class
 - ☞ The SWLAMA will cover all instructor fees (*lodging, travel, etc.*), so that each individual entity will only be *responsible* for their *participants' tuition* and *any equipment needed* for operations level training
 - ☞ **Awareness Portion:**
 - ✓ The maximum class size for the **Awareness portion** is practically unlimited and will cost **\$90** per student
 - ✓ This class is roughly **6** hours long and is recommended for all first responders/emergency personnel
 - ☞ **Operations Portion:**
 - ✓ The ***Operations portion*** will be limited to **25** students and will be offered pending an application process
 - ✓ This class is roughly **8** hours long and will take place on the water at a TBD location
 - ✓ The cost for the Operations portion is **\$200** per student
 - ✓ Students ***must*** also provide their own equipment e.g., ***helmet, PFD, throw bag***
 - ✓ A final revised equipment list will be distributed to those attending class

WEATHER UPDATE (NWS): Roger Erickson, Meteorologist-N-Charge –

Tuesday, July 12, 2022:

Issued at 7:20 am CDT Tuesday July 12, 2022

- **Quick Points from yesterday morning:**
 - ☞ Some more oppressive heat for southeast Texas and central Louisiana this afternoon
 - ☞ Still watching a surface trough of low pressure over the northern Gulf of Mexico. Heavy rainfall that poses a risk for flash flooding is the main concern for portions of the coast between Louisiana and the Florida Panhandle
 - ☞ A Heat Advisory is in effect for southeast Texas and central Louisiana from Noon to 7 PM CDT today. Max heat



index values ranging from 108 to 111 degrees will be possible in the advisory area. Take your heat precautions to prevent heat related illnesses

- ☞ There is still a low potential, 10 percent in the next 48 hours, and 30 percent through 5 days, of tropical development of a surface trough of low pressure over the northern Gulf of Mexico. Basically, gradual development may occur if the trough can stay offshore as it meanders near the coast through the end of the week
- ☞ Regardless of development of the surface trough, heavy rains over the next several days pose a risk of flash flooding. For Wednesday and Thursday, there is a Slight Risk Potential (*level 2 out of 4 on the risk scale*) of excessive rainfall leading to flash flooding for the lower Atchafalaya Basin, basically southeast of New Iberia, and a Marginal Risk Potential (*level 1 out of 4 on the risk scale*) of excessive rainfall leading to flash flooding for the remainder of south-central Louisiana, along with southwest and central Louisiana
- ☞ There is the potential for some tropical downpours that could produce 1 to 3 inches of rainfall in a short period of time in the risk areas. If these rainfall amounts occur, flooding of streets and poor drainage low spots will be possible.



Wednesday, July 13, 2022:

- Warm and muggy starts as temperatures are once again in the middle to upper 70's
- ☞ Sunshine will help to warm us quickly this afternoon and help to trigger some showers and storms
