Trauma

- o Trauma is not what happens to you, it is what happens inside of you as a result of what happened to you
- o It changes us
- o **SAMHSA's definition:** Individual trauma results from an **event**, series of events, or set of circumstances that is **experienced** by an individual as physically or emotionally harmful or life threatening and has lasting adverse **effects** on the individual's functioning and mental, physical, social, emotional, or spiritual well-being



Resilience

- o Resilience is the capability of individuals to cope successfully in the face of significant change, adversity or risk
- o The capacity changes over time and is enhanced by protective factors in the individual and environment
- o (Stewart et al, 1997)
- o Recovery from trauma CAN occur!



- o Includes personal attributes AND organizational attributes
- Personal: Practicing optimism, mindfulness, thinking before we speak, having a positive attitude, accepting help, gratitude, trying new things, setting realistic goals, building relationships, being accepting of change, improving self-esteem, getting good sleep, being physically and mentally fit, practicing relaxation
- Organizational: Authentic culture, managing workloads and stress, building trust, ensuring voices are heard, being flexible, finding strengths, good policies and procedures, has focus, good communication, allows creativity and curiosity, consistency across time, responds appropriately



Increasing Resiliency

- o Increase resiliency of individual workers
 - **Example:** Providing workers with information about insurance coverages
- o Increase the resiliency of institutions
 - > Becoming trauma informed; offering institutions expertise
- o Increase resiliency of the community
 - ➤ Social services sector planning
 - ➤ Policy changes that impede recovery

Consider health at every recovery decision made

What is Recovery?

- o It is more than the community's return to pre-disaster circumstances
- O No single definition fits all situations, but in general, the community successfully overcomes the physical, emotional, and environmental impacts of the disaster; it re-establishes an economic and social base that instills confidence in the community: it rebuilds by integrating the functional needs of all residents and reducing its vulnerability to all hazards facing it; and the entire community demonstrates a capability to be prepared, responsive, and resilient in dealing with the consequences of disasters.

Post-Traumatic Growth

o "As we look to the future, I want to encourage us to think about what might come from the experiences we have faced recently. The decade after the pandemic of 1918 saw the invention of many things, including the grocery bag, hydraulic brake, toaster and blender, polygraph, masking tape and corn dogs. That period also saw the refinement of penicillin, and the invention of insulin and the electrocardiogram." – Susana Rivera-Mills from Leadership in the Time of COVID-19

- State of the Insurance Market Jennifer Mourain, Office of Consumer Advocacy & Diversity
 - Homeowner's insurance is increasing statewide
 - Ex: 2022 **18.5%** increase in rates
 - 2021 6.7% increase in rates
 - 2020 **1.9%** increase in rates
 - o 64% of homes are underinsured according to a national study
 - o Make sure to shop based on the cost value of the house
 - o Increase in catastrophe losses
 - o Increase in supply costs for houses.
 - o 9 insurers failed in the aftermath of Hurricane Laura, Delta, and Ida causing less competition in the insurance market
 - o Louisiana Citizens
 - o 63% rate increase on residential properties
 - Required rate to be at least 10% of the qualifying market
 - o Most Expensive Mistakes?
 - Not knowing your deductible
 - Not having insurance
 - Not having replacement cost coverage
 - Not having enough insurance to cover home
 - Not filing supplemental claims
 - This is done during home repairs
 - o Best Practices
 - Review your policies now
 - Mitigate your property
 - Plan!!
 - Interview your agents for multiple bids
 - Verify if your agent is captive or independent
 - o Responsibilities before a Loss
 - Become an educated consumer
 - Understand the cost and value of your home
 - Notify the insurer of any improvements can increase home value
 - Review your policy for adequate coverage paintings, and expensive hobby equipment
 - Create a home inventory.
 - Maintain your property.
 - > I.e., cut an old dead tree down

- o NAIC Home Inventory App
 - Easier claim process
 - Have a copy of the insurance policy in hand
- Your Responsibilities after a Loss
 - File a claim
 - Make reasonable repairs, but first receive prior approval of insurance copy
 - Keep invoices and receipts OF EVERYTHING hotel, gas, food, etc
 - Take a home inventory.
 - Send proof of loss to the insurance company within 180 days of catastrophic loss and 60 days of perils
- o Catastrophe Reform
 - Insure Louisiana Incentive Program
 - > Successful after Hurricane Katrina and Rita
 - More insurers, more competition, so rates will be driven down
 - Currently, 9 insurance companies are coming to write policies to potentially solve the skyrocketing rates similar to 2005.
 - Fortify Homes
 - ➤ An incentive for homeowners to repair damaged roofs.
 - > \$10,000 grant
- o Set by Business Home and Safety Program
- o Mobile homes and condos do not qualify
- o Must have wind coverage, and flood insurance if living in hazard areas provided by FEMA
- o Opens Oct. 2
- o Citizen Policyholders are given priority.
- o Brings premiums down.
- o If you hire a contractor before approval of the grant, you become INELIGIBLE for the grant.
- o Lasts for 5 years.
- o The completed project must meet the fortified roof requirements.

KPLC 7 Weather: by, Joseph Ink

- FIRST ALERT FORECAST Wednesday, October 11, 2023
 - First Alert Forecast: Some thin showers and gusty winds today, but not enough rain to help with drought
 - LAKE CHARLES, La. (KPLC) -We have another cloudy day ahead for Southwest Louisiana, with some drizzles and showers to keep temperatures down.
 - An area of low pressure has been moving northeast from south Texas across the northern Gulf of Mexico since early this morning, helping to bring some limited rainfall to the area. The best chance of rain will likely remain offshore with chances sharply dropping from south to north across Southwest Louisiana. It is looking much drier for today's estimates as the system is shoved further east; areas farther northwest may see little to no rain, while areas farther southeast could see as much as 1/4 inch to 1/2 inch.
 - Skies will still be staying mostly overcast for the day, which combined with the drizzle and breezy conditions will keep temperatures in the 70's for the day, possibly in the 60's for a handful of areas. The biggest impact will be the wind, with gusts higher than 20 mph possible during the day. A wind advisory is in effect for the coastal parishes







- Some showers will be around throughout the day, but rain totals are looking low(KPLC)
- FIRST ALERT FORECAST Tuesday, October 10, 2023



LAKE CHARLES, La. (KPLC) - Our weather pattern has been shifting with southerly winds and humidity coming back to SWLA, but rain chances won't be picking up until overnight.


Tuesday will continue the trend of increasing humidity, with temperatures and southerly winds both seeing an increase. Generally, overcast skies will be present for the day, which will help keep afternoon temperatures similar to yesterday despite the more humid conditions by keeping us in the shade. Highs for the afternoon will top out somewhere in the low to mid 80's. While rain chances will be picking up soon, it will most likely be late in the evening to overnight.



- Overcast skies for the afternoon Tuesday will keep temps down, but expected to stay dry (KPLC)
- An area of low pressure will move northeast from south Texas across the northern Gulf of Mexico as it merges with a frontal feature; this will bring a chance of rain to our area for Wednesday, trailing into Thursday.



- Low pressure moving to the South will increase our chances for rain Wednesday into Thursday (KPLC)
- The best chance of rain will likely remain offshore with possibly a sharp difference in rain from south to north across Southwest Louisiana. Areas farther northwest may see little to no rain, while areas farther southeast could see upwards of 1 inch of rain with much higher totals possible toward the southeast corner of our state. Generally, models are shoving the better rainfall amounts further to our east.



- Expected rainfall totals(KPLC)
- The National Hurricane Center has also outlined this area for a low chance of tropical development as it moves northeast. However regardless of whether or not it develops the impacts to our area remain the same and in the form of limited rain chances. Even if this manages to develop into a tropical system it would not change our weather with any potential track remaining southeast of our area due to southwesterly upper-level winds pushing this off to the northeast. Impacts could be higher well east of our area from New Orleans into the Florida panhandle, which will be something to keep in mind if you plan to travel that way.



- Tropical Outlook(KPLC)
- Past the rain, another cold front is expected to arrive sometime Friday. It doesn't look like this front will have much moisture, which will keep rain chances limited. However, it will bring another round of cool and dry air to Southwest Louisiana just in time for the weekend! Lows will be returning to the 50s and highs in the 70s by Saturday, remaining nice well into next week. At this time, it looks like the weather may cooperate for the annual solar eclipse which occurs Saturday around 12 pm, more details on that later this week.
