- Oil Well Blowout
 - **Date of Incident:** Friday, June 23, 2021 thru Sunday, June 25, 2021
 - Location of Incident: 4800 Edgerly Road, DeQuincy, LA 70633
 - **Business Name:** Daylight Petroleum
 - **Owner:** Tip Harris
 - Remarks: Ward 6 Fire Protection District No. 1, was paged out at 17:10 hours on 6/23/2021, to respond to a leak from an oil well in the 4800 block of Edgerly Road. Upon arrival, the homeowner at 4850 Edgerly Road, met us at the driveway leading to the oil well site and stated, "that there was something blowing out of the well". She showed *Chief Todd Parker* a video that she had taken of the leak. *Chief Parker* went into the well site and found a liquid substance blowing from the well, along w/a vapor cloud over the site.

Chief Parker immediately left the site and established Incident Command. A fire dept team to recon the area around the release in the warm zone, in an attempt to gather information, on the owner of the well site. Signage at the site indicated it was owned by Forest Oil, however, fire department personnel were unable to contact anyone from that company because the listed emergency numbers were all non-working numbers. Chief Parker had Calcasieu 911 contact the Louisiana State Police Haz-Mat hotline at 17:23 hours.

Fire department personnel and apparatus remained on scene in order to provide fire protection until being released at 16:00 hours on 6/25/2021. CPPJ command center also left the staging area at 16:00 hours on 6/25/2021.
